Shared Ride Program

Rhineland Public Transit provides a shared ride taxi service for the general public within the City of Rhineland and its 20 mile radius. The service is a door-to-door, demand-responsive, advanced reservation, shared ride taxi service. Other passengers may be picked up or dropped off during your trip.

Hours of operation are 24 hours a day, 7 days a week, including all holidays.

Rhineland Public Transit provides a wheelchair accessible van and allows one caregiver to ride along for free.

It is recommended to make advanced reservations, at least one day in advance, for services going out of town.

This system is subsidized with state and federal transit operating funds. Hiring out vehicles or contracting for private events or school bus service is prohibited.

Fares per one way ride

Trips within city limits of Rhinelander

General Public.....	\$4.00
Child (under 6 yrs. with an adult).....	Free
Senior (60+) or Disabled.....	\$3.00
Additional Passengers.....	\$1.00 (same location to same destination)
Agency.....	\$7.00

Trips outside city limits of Rhinelander

General Public.....	\$4.00 + \$2.00/mile
Senior (60+) or Disabled.....	\$3.00 + \$1.00/mile within 10 miles
Senior (60+) or Disabled.....	\$3.00 + \$2.00/mile over 10 miles
Additional Passengers.....	\$1.00 (same location to same destination)
Additional Passengers beyond 20 miles.....	\$5.00
